**ENCROACHMENT REQUIREMENTS**  
**CONDITIONS OF APPROVAL:**

1. THE PERMIT HOLDER AGREES TO COMPLETE THE CONSTRUCTION OF THE ENTRANCE AS DIRECTED, PRIOR TO ANY OTHER WORK BEING INIATED ON THE PERMITTED PROPERTY.
2. THE PERMIT HOLDER AGREES TO MAINTAIN THE ENTRANCE INCLUDING ANY REQUIRED PIPE IN ITS APPROVED CONDITION DURING THE PERMITTED CONSTRUCTED.
3. THE PERMIT HOLDER WILL LIMIT INGRESS AND EGRESS TO THE APPROVED ENTRANCE DURING THE PERMITTED CONSTRUCTED.
4. THE PERMIT HOLDER AGREES TO ACCECT RESPONSIBILITY FOR ANY FOREIGN MATERIAL DEPOSITED UPON THE COUNTY ROAD AS A RESULT OF CONSTRUCTION AND SHALL IMMEDIATELY REMOVE SAID MATERIALS.
5. THE PERMIT HOLDER AGREES TO PROMPLY REPAIR THE COUNTY'S RIGHT-OF-WAY, RESULTING FROM HIS ACTIONS OR THOSE OF HIS AGENTS TO INCLUDE ROADWAY, DITCHES, SHOULDERS, ETC. DURING THE PERMITTED CONSTRUCTION.
6. AT ANY TIME DURING THE CONSTRUCTION ON SAID PROPERTY, FAILURE TO COMPLY WITH THE TERMS OF THIS PERMIT SHALL RESULT IN A STOP WORK ORDER TO INCLUDE ANY CONSTRUCTION ON SAID PROPERTY.
