AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF
ORDINANCES OF THE COUNTY OF OLDHAM, KENTUCKY

WHEREAS, American Legal Publishing Corporation of Cincinnati, Ohio has completed the S-2 supplement to the Code of Ordinances of the County of Oldham, which supplement contains all ordinances of a general nature enacted since the prior supplement to the Code of Ordinances of this municipality; and

WHEREAS, American Legal Publishing Corporation has recommended the revision or addition of certain sections of the Code of Ordinances which are based on or make reference to sections of the Kentucky Revised Statutes;

WHEREAS, it is the intent of the Legislative Authority to accept these updated sections in accordance with the changes of the law of the Commonwealth of Kentucky;

NOW THEREFORE, BE IT ORDAINED, by the County of Oldham;

SECTION 1. That the S-2 supplement to the Code of Ordinances of the County of Oldham, Kentucky, as submitted by American Legal Publishing Corporation of Cincinnati, and as attached hereto, be and the same is hereby adopted by reference as if set out in its entirety.

SECTION 2. That this ordinance shall take effect and be in force from and after its passage, approved and publication required by law.
