APPROVAL OF AGENDA:

Motion made by Magistrate Dye and seconded by Magistrate Haunz to approve the agenda with the addition of the LaGrange Utilities / MSD Interlocal Agreement at the end of the agenda. Motion carried unanimously.

APPROVAL OF MINUTES:

PUBLIC COMMENT:

Jim Allen, Chairman of Crystal Lake Road District, 1416 Oldham View Dr., LaGrange, KY 40031, addressed the court and thanked the county road department for their speed and effort to fix a sinkhole that suddenly happened in the Crystal Lake Road District.

Amy Alvey, County Clerk, announced the deadline to register to vote is April 22, 2024 at 4 pm. The absentee ballot portal is open to sign up until May 7, 2024. There will be absentee ballot boxes at all 3 county clerk offices. The election information cards have been mailed to all homes in Oldham County. Voting will take place on May 21st from 6 am – 6 pm. Chief Greg Smith, Oldham County Police, announced a successful evening shift under the command of Sgt. Durrett with officers apprehending speeders and reckless drivers on I-71 as well as large seizures of narcotics and weapons being passed through our county.
