Magistrate Likins expressed that the Fourth of July fireworks were great and thanked everyone involved in making the event happen.

Magistrate Harrison made the following comments:

- July 27th is Korean War Veterans Armistice Day.
- August 4th is the birthday of the Coast Guard.
- Invited all Purple Heart recipients to the Fiscal Court meeting to be recognized on August 4th as August 7th is National Purple Heart Day.
- Reported that the bridge at 1488 (Organ Creek Rd.) is almost complete. He plans to stop at noon on Friday to say thank you to the crew.
- Stated that mowing had begun on Highway 42 and 524.
- Announced the passing of Jim McWilliams, the former PVA of Oldham County. Jim had succeeded his father, Buddy McWilliams, in the PVA position. No services are planned.

Judge-Executive Voegele made the following comments:

- Reiterated Magistrate Hawkins announcement that John Black Community Center is accepting reservations of a limited number of people that will observe social distancing.
- Communicated his concern of moving forward with events such as the Oldham County Fair. If the fair does take place, social distancing rules must be observed and patrons must wear masks.
- Recalled the North Oldham High School party which resulted in many people with symptoms and one confirmed, positive Covid-19 case.
- Reported on a local pastor who is in the hospital, struggling with symptoms resulting from Covid-19 and reminds all that this is a serious situation and to use caution.
