September 1, 2020

The Oldham County Fiscal Court convened at a regular meeting at 2:00 p.m., with Judge-Executive David Voegele, County Attorney, John Carter, and the following Magistrates in attendance: Brent Likins, Wayne Theiss, Albert Harrison, Steve Greenwell, Chris Haunz, Stephanie Hawkins, Bob Dye, and Michael Logsdon.

The court observed a moment of silence in admiration for his service, but sadness with his passing for Nate Bourke, a 1998 graduate of Oldham County High School and a member of the Army National Guard.

APPROVAL OF AGENDA:

Motion made by Magistrate Dye and seconded by Magistrate Greenwell to approve the agenda as submitted. Motion carried unanimously.

APPROVAL OF MINUTES:

Motion made by Magistrate Haunz and seconded by Magistrate Likins to approve the meeting minutes from August 18, 2020, as submitted. Motion carried unanimously.

PUBLIC COMMENT:

Janet Bowman of LaGrange addressed the court regarding how she has been treated by members of the medical community.

Becky Zocklein, Solid Waste/Recycling and Grants Coordinator, announced the following:

- The drive-thru household hazardous waste collection is scheduled for Saturday, October 3 from 9 a.m. 3 p.m. at the Oldham County fairgrounds.
- National Clean-up Day is September 19. The citizens of Oldham County are invited to design their own method of cleaning up to make an impact on the environment.

Motion made by Magistrate Greenwell and seconded by Magistrate Harrison upon recommendation of the County Engineer to award the paving bid for the fall 2020 county projects to Libs Paving alternate #2 bid including overlay in the amount of \$1,120,720.82, as submitted. **Exhibit #14 9/1/20** Motion carried unanimously.

PUBLIC COMMENT:

None.

ANNOUNCEMENTS:

Magistrate Logsdon expanded on Nate Bourke's story.

Magistrate Hawkins announced the Parks Committee would like to start engaging the Magistrates, then the public in a conversation about the Schamback Park project and what they would like to see in Oldham County public parks.

Magistrate Haunz announced the following:

- He attended the Gold Star Families Memorial Monument dedication and urges everyone to view the monument.
- Reminded everyone the anniversary of 9/11 is approaching and we should never forget.
- With some schools back to in-person learning, he encouraged all citizens to be careful of pedestrians walking on the roads and instructed that it is best to walk towards traffic.
- Reiterated Lit Communities has been hired to push forward the broadband initiative and very soon an e-mail will
 be sent regarding a survey to complete. The three issues about which he hears from his constituents most are:
 internet, cleaning out ditches and speeders, so it will be very important to receive feedback from the broadband
 survey.

Magistrate Greenwell recalled walking through the Gold Star Families Memorial Monument and reported it is worth visiting.

Magistrate Harrison made the following announcements:

- September 11 is Patriot Day.
- September is Service Dog Month.
- The census will be setting up locations throughout the county to assist citizens in completing the Census questionnaire.
- Regarding Memorial Park, in December of 1967 he had to write a letter to the parents of a young man who served
 with him and had been killed which brought him into the Gold Star family venue and which makes it difficult to visit
 Memorial Park.

Magistrate Theiss recalls that it has been a difficult year thus far, however, he hopes everyone finds patience and finds their way through being careful along the way.

Magistrate Likins reported the Building and Maintenance Committee interviewed three architectural firms regarding the new Animal Control building. The committee agreed unanimously that Architectural Investments is the best firm based on their experience and daily maintenance of facility, but the project will cost an estimated \$3-4 million. This will require a budget amendment which will be addressed at the next Building and Maintenance Committee meeting.

Magistrate Dye stated there were census enumerators out in the community and Kentucky is reported to be 2% better than the national average in response to the U.S. Census Bureau questionnaire with Oldham County at a 90% response rate

Judge-Executive Voegele further commented that Oldham County currently ranked #7 in the country for responses. Also, he wished Judge Karen Conrad well on her retirement.

MEETING ADJOURNED:

Motion made by Magistrate Dye and seconded by Magistrate Haunz to adjourn the meeting. Motion carried unanimously. The meeting adjourned at 4:05 p.m.
